VENDOR TERMS & CONDITIONS

BOOTH LOCATION

Location of booths will be the responsibility of the Chase & District Festival Society Market Manager. Requests will be considered and can be made on the application form.

RESTRICTIONS

The Chase & District Festival Society Market Manager and the Chase & District Festival Society Committee reserve the right to refuse booths. We promote family oriented goods. ABSOLUTELY NO knives, lighters, articles with profanity, drug paraphernalia, etc. are allowed to be sold at any Chase & District Festival Society Markets in 2017. Please pay particular attention to wording on t-shirts and hats. If there are any questions to the suitability of a particular item, it will be up to the Chase & District Festival Society Market Manager to make a determination.

SET-UP TIME & HOURS OF OPERATION

CANADA DAY CELEBRATIONS - SATURDAY, JULY 1, 2017.

You may begin to set up your booth on Saturday, July 1st, 2017 between 11:00am to 1:00pm. All booths must be set up by 1:00pm. The day's main festivities will run from 2:00pm to 11:00pm (times may change). All booths must be staffed and in operation between the hours of 1pm and 6pm on Friday July 1st, 2016. You may choose to remain open until no later than 10pm, however, please keep in mind that lighting in the Market area will be limited.

CORNSTOCK FESTIVAL - SATURDAY, AUGUST 12, 2017.

You may begin to set up your booth on Saturday, August 12th, 2017, between 12:00pm to 2:30pm. All booths must be set up by 3pm. The day's festivities will run from 3pm to 10:00pm (times may change). All booths must be staffed and in operation between the hours of 3pm and 7pm on Saturday, August 13th. You may choose to remain open until no later than 9pm, however, please keep in mind that lighting in the Market area will be limited.

MUSIC ON THE LAKE ~ SUMMER MUSIC SERIES - TUESDAYS, JULY & AUGUST 2017.

You may begin to set up your booth between 4:00pm to 5:30pm. All booths must be set up by 6:00pm. The day's events will run from 6:00pm to 8:30pm. All booths must be staffed and in operation between the hours of 6pm and 8:30pm on the evening of the event. You may choose to remain open until no later than 9pm, however, please keep in mind that lighting in the Market area will be limited.



PAYMENT INFORMATION

A non-refundable FULL PAYMENT is required **10 days prior to any event**, or else you may lose your spot as a Vendor. Cash, Cheques, or Credit Card payments are accepted and should be made payable to **Chase Festival Society**. If paying via credit card, please indicate this on your application and an invoice will be emailed to you through PayPal.

SITE SERVICING FEES & REQUIREMENTS

- Food vendors that require electricity are encouraged to provide their own generators as access to power is limited. If an electrical hook-up is needed please specify this on your application form and the Market Manager will be in touch.
- The Chase & District Festival Society Committee is responsible for providing space only. **Tents, tables, etc. are the responsibility of the vendor.**
- All Vendors are required to provide a tent or some form of shelter for their space (and ensure that it is anchored properly). If you feel this will hinder your booth/presentation area, please indicate this in the "Site Requirements" on the application form and we will contact you to discuss other options.
- All equipment must meet the standard health and fire safety and operating regulations. All Vendors must meet the criteria or standards of the Interior Health Authority, the RCMP, the Chase Fire Department and any other regulated authority.
- Pursuant to all applicable regulations, all Food/Concession Vendors must have an approved fire extinguisher. All Food/Concession Vendors should note that the Interior Health Authority and the Chase Fire Department may be on site to conduct inspections of food preparation and serving facilities and equipment.
- Booth maintenance and site clean-up is the sole responsibility of each Vendor.
- All used cooking oil must be removed from the park by the Vendor.
- All Vendors spaces are an initial 10' x 10' space. Additional space may be granted (at no extra cost), but cannot be guaranteed until after the Application Deadline. Please note that no additional booth space can be added to your site once you arrive in the park; therefore ensure you request sufficient space for your vendor/booth site and that the frontage is listed correctly on the application.
- Only Food/Concession Vendors will be guaranteed spots with vehicle parking directly behind. All other spots will have access to a loading/unloading area and free onsite parking within a short distance from the booth.

The Chase & District Festival Society, its volunteers, agents, the property owners, management, etc., shall not be liable to the Vendor, their employees, agents, or customers for any personal injury or damage to property. Everything brought to the festival premises by the Vendor, their employees and agents or customers, shall be entirely at the risk of the Vendor or others for any loss or damage in accordance with Canadian Insurance Laws. The Vendor shall be responsible for the insurance of his own property.

NON COMPLIANCE WITH ANY OF THE ABOVE WILL RESULT IN NON-ACCEPTANCE AND/OR BEING REMOVED FROM THE SITE WITHOUT REFUND.
